

## Directions to Rincker Law, PLLC's Champaign, Illinois Office


Come visit Cari Rincker and her team at her office located in the **M2 Building** by the Hyatt in Downtown Champaign: **301 N Neil Street, Suite 400, Champaign, IL 61820**. If you have any problems finding the office, you can call Cari at **(217) 531-2179** or email her at **cari@rinckerlaw.com**.

You may enter the building from a few places. The main entrance is off of Neil Street near the restaurant Destihl. You can also enter through the side alley or from the parking garage attached to the building.

When you enter the building, please come to the 4<sup>th</sup> floor and tell James and Rena at reception that you have an appointment with Cari. Feel free to help yourself to coffee, soda, water or vending machine snacks in the breakroom left of the elevators. Please do not bring children as childcare is not available and Cari would prefer not to speak about personal and confidential issues in front of children.

### Parking

The **Hill Street Parking Deck** is attached to the M2 Building and is operated by the City of Champaign. Rincker Law, PLLC will validate parking at the Hill Street Parking Deck for up to 1 hour; afterwards, the cost is \$0.75 per hour (\$7.50 daily maximum). You may enter the parking garage from **N. Randolph Street** between W Church Street and W. Hill Street or on **W Hill Street** between N. Randolph Street and N. Neil Street.



There is also a public parking lot across the street from the M2 Building, near Kofusion and Big Grove restaurants. If you forgot quarters, you can pay with the MobileMeter app at the **Neil & Washington Lot**, identified to the right:

### **Driving Directions**

#### **From I-72**

Head east on W University Ave toward S Mattis Ave  
Turn left onto N Randolph St  
Turn right onto W Hill St  
Turn right onto N Neil

#### **From I-57**

Take I-57 S and I-74 to N Neil St. Take exit 182 from I-74  
Turn right onto N Neil

#### **From I-74**


Take exit 182 for Neil St Turn south onto N Neil St  
Destination will be on the right

#### **From University of Illinois Urbana-Champaign Willard Airport**

Follow Airport Rd to US-45 N/S Dunlap St  
Turn left onto US-45 N/S Dunlap St  
Continue to follow US-45 N  
Take S Walnut St to N Neil St  
Destination will be on the left

#### **From Route 45**

Take S Walnut St to N Neil St  
Destination will be on the left



## Bus Directions

Rincker Law, PLLC is accessible via the MTD: Champaign-Urbana Mass Transit District. The 3, 5, 6, 7, 30 and 50 busses stop on **University & Neil**, about 2.5 blocks away from the office. Additionally, the 1, 5, and 50 busses stop on **Randolph & Clark**, about 3.5 blocks away from the office.
