

## CENTRAL ILLINOIS PARTNER ABUSE INTERVENTION PROGRAMS

The Department of Human Services funds and/or monitors Partner Abuse Intervention Programs across the state. These programs provide domestic violence perpetrator services such as assessment, individual and group education, and case coordination with referral sources. These services help perpetrators accept responsibility, modify abusive attitudes and beliefs, and give them tools to become and remain, healthy non-abusive partners and parents. The contact information listed may refer back to the main agency; however, the services are being offered in the city/community posted, both by private agencies and by government. All programs offer services in English.
